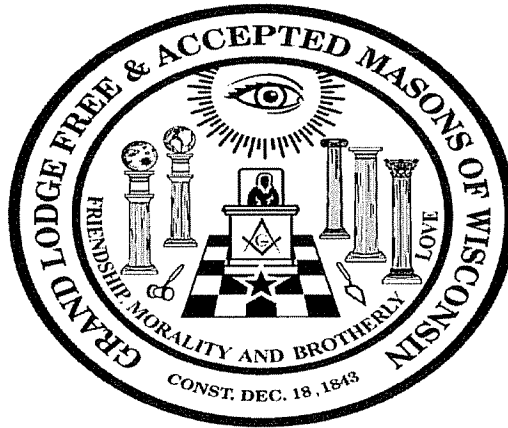

**LAWS OF THE GRAND LODGE**

**Chapter 26 - Grand Lecturer**

**26.01 Shall Visit and Instruct Lodges. *Each lodge in this Grand Jurisdiction shall be instructed at least annually by the Grand Lecturer or District Lecturer unless the Grand Master shall otherwise order. The Grand Master may, in his discretion, order additional instruction in any lodge upon such terms as he may deem proper; lodges desiring additional instruction may obtain it by arrangement with their District Lecturer.***

## **Schools of Instruction Schedule District No. 4**

All Schools of Instruction are from 9 am until 3 pm, \*unless otherwise listed. The hosting lodge provides refreshments and lunch, and will open with its officers in the respective degree. Those lodges having two evening Schools do not need to provide a lunch. All other parts will be assigned amongst the brethren, with the Proficiency Men and Ritualists assisting in the instruction. Proficiency Men and Ritualists must attend a school to have their cards renewed. Each school will focus on a narrower portion of the work (see items listed below), that will enable us to have more time to evaluate and review problem areas. It is essential that each Master plans for their School of Instruction and motivates his officers and members to attend. Masters, please contact the hosting lodge with a head count at least one week in advance.

- Item 1**      **Open Lodge of EA, do 1<sup>st</sup> Section, receive a Grand Officer, enter a tiled Lodge, close a Lodge of EA.**
  
- Item 2**      **Open a Lodge of FC, purge and take up the Pass, Ballot, do 1<sup>st</sup> Section, receive a Gran Officer, receive the flag, call down to EA and resume labor in FC, close a Lodge of FC.**
  
- Item 3**      **Open a Lodge of MM, receive a Grand Officer, do 1<sup>st</sup> and 2<sup>nd</sup> Section of MM, close a Lodge of MM.**
